Digital Disruption: How Canadian Music Creators can make the transition?

Toronto, Canada – February 3rd, 2020 - The Screen Composers Guild of Canada today announced the launch of *Digital Disruption: How Canadian Music Creators can make the transition.* This exciting joint research initiative between the **Screen Composers Guild of Canada** (SCGC), **Songwriters Association of Canada** (S.A.C.) and **Société Professionnelle des Auteurs et des Compositeurs du Québec** (SPACQ), is funded by the Canada Council for the Arts under its Digital Strategy Fund, and conducted by strategic and consulting firm Nordicity. This multi-stage research project will take place over the next six months, and will investigate the ways in which music creation in Canada has been disrupted by the introduction of streaming platforms such as Netflix and Spotify, and explore how music creators can successfully meet the challenges presented by this rapidly evolving digital landscape.

John Welsman, President SCGC: "This research is necessary to understand the fundamental structural changes that have made it increasingly difficult for songwriters and composers to make a living, and to pursue sustainable solutions, be they technological or policy-based. It is imperative for us to uncover strategies that might help reverse the trends that have so negatively impacted music creators."

Greg Johnston, President S.A.C.: "As digital disruption continues to impede creator's access to fair and transparent remuneration streams, there is increasing urgency to alleviate the downward pressure on creators that the "value gap" has exerted. This research is essential to determine strategies, policies, and "best practices" to avoid further erosion of creator's rights, revenues, and to restore an economic environment that fosters their creative cultural output."

Edgar Bori, President SPACQ: "This research is essential for the music creators to better understand exactly why and how they have lost so much revenue from the exploitation of their works in the digital world. Additionally, we hope to propose viable solutions for creators to receive fair and decent revenues."

The research will benefit thousands of music creators in Canada belonging to the SCGC, S.A.C. and SPACQ as well as hundreds of thousands more music creators around the world. The research will examine ways to protect and sustain a vital creative sector, as well as assist the work of rights collectives (e.g. SOCAN) in their efforts to collect and distribute royalty income that is crucial to every music creator's livelihood.

The Songwriters Association of Canada (S.A.C.) represents 1000 Canadian music creators including songwriters, composers, beat makers, producers, and top-liners from across the country, in all genres of music.
